BARRIERS IN THE INTERPERSONAL COMMUNICATION OF CAREGIVERS TO OLDER ADULTS WITH A CHRONIC DISEASE RECORD

Abstract

Continuing care for older adults requires interpersonal communication support based on their needs. This affects the ability of older adults to adapt and recover from declining physical conditions. The purpose of this study was to understand the communication carried out by a family member as the main caregiver and healthcare provider of an older adult with a chronic disease record. The method used was a case study. An in-depth interview was conducted with a family main caregiver of a 78 year older adult with chronic gout and persistent high cholesterol level. There are communication barriers encountered by the caregiver as a result of unclear information given, disobedience to the doctor's instruction, and previous unhealthy eating habits. These barriers lead to the caregiver feeling exhausted to support the older adult in achieving a healthier lifestyle. Related to the healthcare provider, unfair treatment characterized by unfriendly behavior, lack of information, and no respect for the older patient and their family member, as a result of using the National Health Insurance (BPJS) were acknowledged by the caregiver. This experience makes the patient and family feel offended. The caregivers must provide empathic communication patterns, build positive behavior in the family, and trigger intrinsic motivation so that the older adult can see that they are investing in a meaningful goal by pursuing a healthy lifestyle. Professional healthcare workers need to communicate well with older adults and their family members by listening actively, being a trusted source, and maintaining equality to build positive, open communication and mutual respect.

Nonverbal correspondence is generally perceived as the course of correspondence through sending and getting silent messages (Farr, 1962 as cited in Jasim & Aziz, 2010) or word messages that might contain non-verbal components known as paralanguage, including voice quality, feeling, and talking style, just as prosodic highlights like mood, inflection, and stress (Poyatos, 1981). Abstract

The application of interpersonal communication is important in caring for older people with dementia. Family caregivers and health professionals need to be more sensitive to their needs to build an effective and optimal treatment. The purpose of this study was to obtain an overview of interpersonal communication carried out by family caregivers and health providers to older adults with dementia. The method used was a case study. An interview was done with the main caregiver in the family who has a female, 80 years old family member, with dementia. Communication barriers were felt by the family caregiver due to emotional changes in the older adult with dementia. Feeling alone, crying for no reason, and an increased frequency of anger are emotions that afflicted the person with dementia. In some healthcare providers, unfriendliness, and lack of initiative to communicate and give information were found. The COVID-19 pandemic also affected the proxemic communication between health professionals and dementia patients. Maintaining physical distance to reduce the transmission of COVID-19 was perceived as a form of neglect from healthcare providers to the patient and the family. In addition, because health workers used personal protective equipment, physical touch become very minimal hence emphatic approach was felt to be reduced. It is necessary to build the initiative of the family's main caregiver and healthcare professionals to explore the concerns of older individuals with dementia by always prioritizing the principles of mutual trust relationship and openness. Training for family caregivers and professionals is needed to improve their awareness regarding the biopsychosocial spiritual problems faced by older adults with dementia and to enhance their skills using appropriate communication strategies.

CORPORATE STRATEGY OF TAX AVOIDANCE IN THE NEW NORMAL

Abstract

This study aims to examine the effect of thin capitalization, profitability, and company size on tax avoidance before and when a pandemic occurs. The method used is a quantitative approach with multiple linear regression analysis, and difference in difference (DID) analysis, which will be processed by STATA 13 software. The sample of this study is the financial statements of 93 manufacturing companies with total observations of 279 companies registered on the IDX in the period 2018-2020. ROA has a significant positive effect on tax avoidance before and when a pandemic occurs, while thin capitalization, ROE, and company size don't have a consistent effect. Research shows the CETR measurement has a higher value than the other measurements (ETR and BTD). DID analysis showed a reduction in tax avoidance across all measures (ETR, CETR, and BTD).

Lockdown and Social Distancing are some of the Government of Indonesia's policies to control the mobilization of their people to reduce the spread of Novel Coronavirus or usually known as COVID-19. As a result, these policies have impacted many sectors, especially in the education system. Practicum is an important activity for the students to improve their hard skills that are required for the major that they chose before. The limitation of the room for education which is caused by the pandemic impacted the practicum activity directly. This situation could happen because of the regulation for education institutions to always conduct online learning during this pandemic. Pharmacy is one of the majors that require practicum activities because the students are required to formulate and dispense medicine. Along the time, technology has been used to support the new way of learning either in full-online practicum or hybrid e-learning. The purpose of the research is to examine the perception of Pelita Harapan University students about online practicum learning, the knowledge, and the impact of skilled onsite practicum. This research uses a qualitative analysis method with a restricted data collection technique. Based on the data, students received the material in its entirety from various online practicum approaches such as presentations, internal, and external practicum videos, and live practicums provided by the practicum supervisor. 59 percent of the respondents can understand K3 and acknowledge the relationship between theory and the result of the examination at the practicum. With the model of practicum that has been run, 60 percent of the respondents can understand the main point of the subject that they had taken before, 58 percent of the respondents agree that they can do the onsite practicum well and 76 percent of respondents agree that the model of the practicum is the most optimal and safe during the pandemic situation. The student perceptions about the online practicum are positive based on the 78.5 percent of positive responses. In general, the online practicum is quite effective in helping students understand basic theory, use of tools and materials, as well as practicum procedures and discussions. Although most of the students answered about network and communication problems, all the online and hybrid practicum approaches that have been taken are optimal and safe efforts for practical learning during the pandemic.

Abstract
